**I.     Subject of the Contract:**

The Contractor agrees to provide meals (lunch) to the above student at the registered seat of the **Gustave Eiffel French School of Budapest** (hereinafter: "**Institution**") at 1029 Budapest, Máriaremetei út 193-199. on the school days of the school year.

**II.    Card system and choice of menus:**

The Contractor provides the service through a card-based system. The first card is provided by the Contractor to the student free of charge, and replacements cost HUF 1,500 each. The student can use the card to order **menu A, B, C or D** either at the ordering terminal located near the Institution's buffet or via the Contractor's online interface at <http://rendeles.eurest.hu/french/> no later than 9:00 a.m. on the day before the day of the meal. If the student does not place an order in advance, then they will automatically receive menu A.

VI. **Cancellation of meals:**

If the student is absent from school, the Client may cancel a meal in writing by sending an email to [francia@eurest.hu](mailto:francia@eurest.hu) no later than 8:00 a.m. on the given day. The price of meals cancelled due to absence will be deducted from the amount of the next invoice. No deduction is possible if a meal is not cancelled.

VII. **Miscellaneous:**

Any amendment to this Contract shall be made in writing by the mutual agreement of the Parties.

The Parties agree that they shall fully comply with the provisions of any applicable statutory regulation in exercising their rights and fulfilling their obligations arising from this Contract.
